**Teachers'/Occasional Teachers' Bargaining Unit President, 2021-2023.** Working to uphold the terms of the collective agreements during one of the most trying times in recent history. I have done my utmost to foster positive relationships at all levels to achieve resolutions to ongoing issues. I continue to specialize in member protection by pursuing further training in conducting workplace investigations. We are also finally entering the first phase of issuing rebates to deal with surplus funds currently being held in trust by OTIP.
